CFD Chief Hits the Slopes on Customized Skis

CLAREMONT, NH—"I have two passions, firefighting and skiing," says Claremont fire chief Bryan Burr. "I thought these would be the perfect way to combine them."

"These" turn out to be Burr's skis, which feature images of his chief's badge, the city's fire station, a 9-11 commemorative patch, and a medal of valor awarded for his part in a Sugar River water rescue in January 2002.

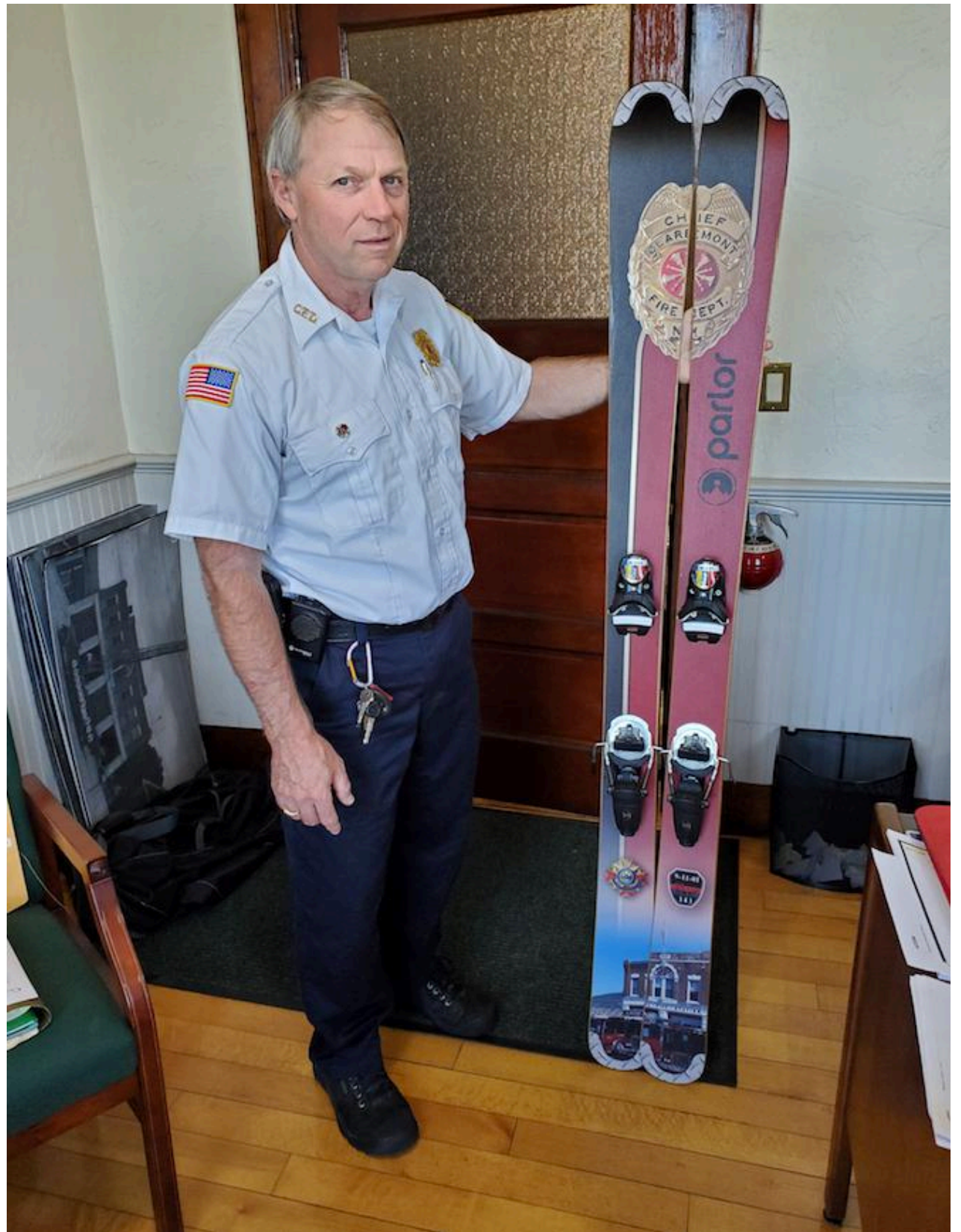
Burr provided the photos to Parlor Skis in East Boston, Mass. The company digitized the images and laminated the graphics directly on the skis.

Burr started his second season on his special skis at Killington on Veterans Day. "It couldn't come fast enough," he says. "I last skied in April. I thought about skiing every day this summer. The conditions were great that day. Of course if you grow up in the East, you're born on ice, so any condition is fine for me."

A self-described advanced skier, Burr notes, "I don't race, never have. I ski for the pure pleasure of it." His wife, Cindy, is also an excellent skier, he adds. Together, they make the rounds of New Hampshire and Vermont resorts, especially Okemo, in Ludlow. "Cindy and I go there a lot," says Burr. They've also skied out

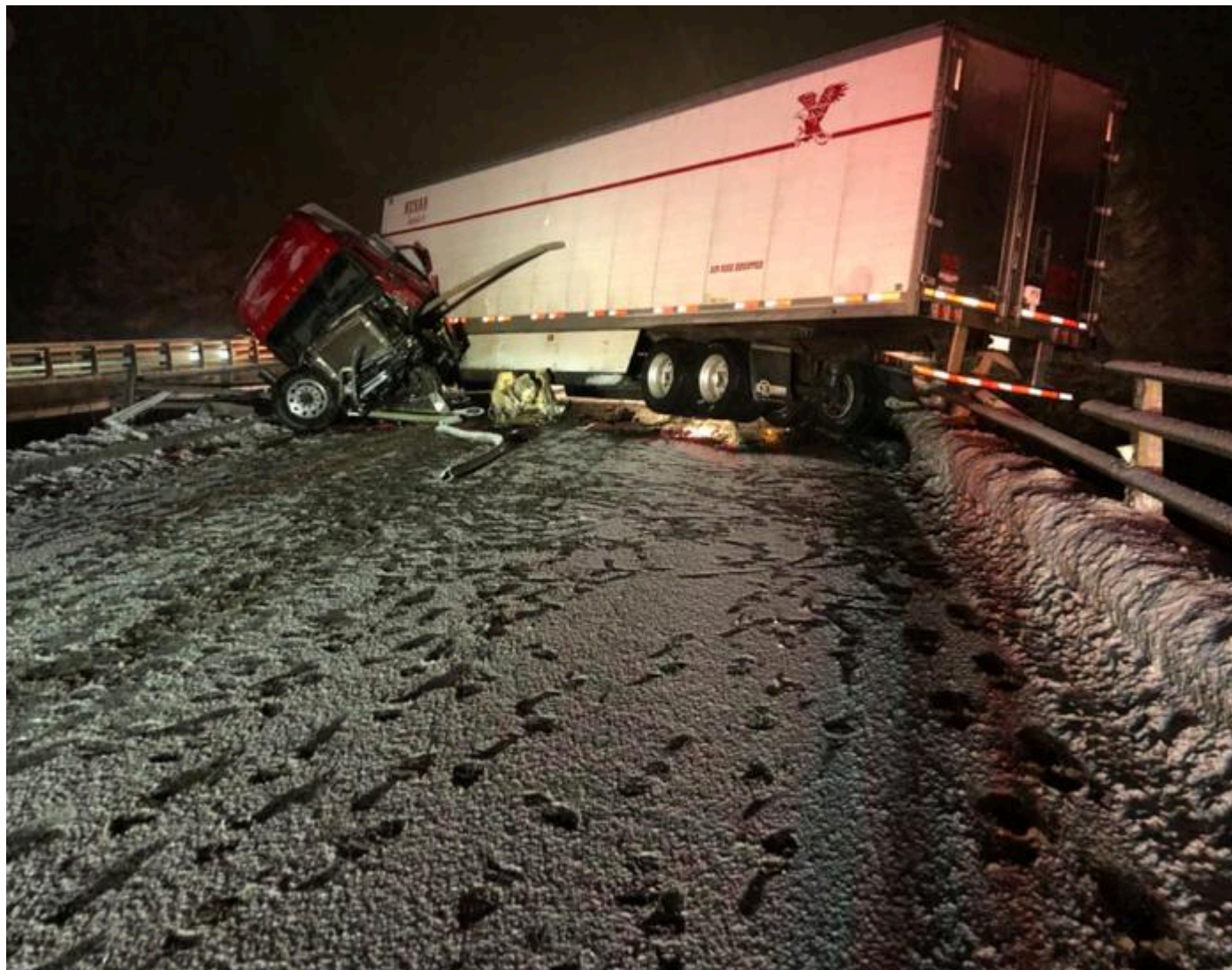

Shaheen, Murkowski Unveil Bipartisan Fix to Tax Bill to Provide Relief to Communities & Companies Unfairly Taxed on Critical Water Infrastructure Investments

WASHINGTON, DC— U.S. Senators Jeanne Shaheen (D-NH) and Lisa Murkowski (R-AK) have unveiled new, bipartisan legislation that would fix an unfair measure in the Tax Cuts and Jobs Act of 2017 (TCJA), which has led to exorbitant taxes on critical water infrastructure investments in New Hampshire, Alaska, and across the nation. Senator Hassan (D-NH) is also a cosponsor of the bill.

The TCJA made adjustments to the Contribution In Aid of Construction (CIAC) tax. Previously, water and wastewater utilities were exempted from this tax; however, the TCJA reinstated the CIAC tax on these entities, which will either have to be covered by state and local governments or passed along to the ratepayers and property taxpayers. These changes have already resulted in \$1.15 million in new federal taxes for water infrastructure projects in Southern New Hampshire and will serve in the future as a strong disincentive against investments in water infrastructure and community development.

“Water infrastructure is vital to economic development and fundamental to delivering clean drinking water. Communities across New Hampshire have been planning projects for years that are now threatened by this new tax,” said Shaheen. “Congress should be encouraging infrastructure development which is why we need to fix this tax bill that was rushed through Congress. I appreciate Senator Murkowski’s support on this bipartisan, common-sense effort and I urge more members to join us so our communities can make urgently needed investments in clean and safe drinking water.”

“I am pleased to join Senator Shaheen in introducing a bill to restore tax-exempt status of contributions in aid of construction received by water utilities. Many water and sewer utilities in Alaska rely on contributions of homebuilders and others interested in expansion of service to offset the cost of service build-out. In the absence of this, the cost gets passed on to customers in the form of higher bills. I have said from the start that the Tax Cuts and Jobs Act had room for improvement, and this legislation is a positive step towards fine-tuning the tax reform bill to bring relief to those who already struggle to face the high costs of basic water and sewer service in a state like Alaska,” said Murkowski.

Kuster Votes to Pass Bipartisan Legislation to Combat Illegal Robocalls

WASHINGTON, DC—Wednesday, Rep. Annie Kuster (NH-02) voted in favor of the Telephone Robocall Abuse Criminal Enforcement and Deterrence (TRACED) Act, which passed the House this afternoon. This bipartisan legislation protects American consumers from robocalls, fraud, and abuse.

“All Americans know what it’s like to receive countless unwanted and bothersome robocalls, often multiple times a day,” said Kuster. “This legislation will help put the American consumer back in control and reduce the frequency of these incessant, disruptive calls. I’m pleased the House and Senate came together in a bipartisan way to pass this commonsense and much-needed bill, and I urge the President to swiftly sign it into law.”

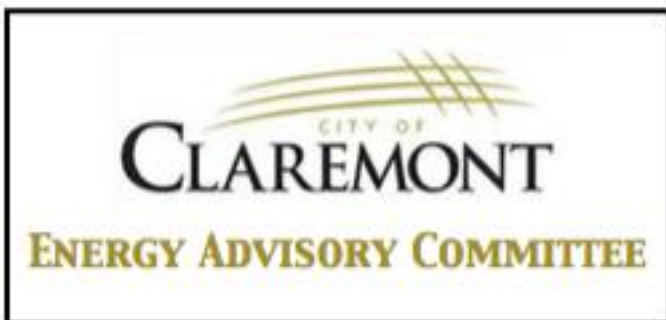
The legislation would help combat illegal robocalls by creating significant penalties for violations of the ban on certain robocalls. This legislation also requires the Federal Communications Commission (FCC) to institute a rule to help protect a subscriber from receiving unwanted calls or texts from an unauthenticated number. The TRACED Act was led by Senator John Thune (R-SD) and Chairman Frank Pallone (D-NJ).

The legislation will now head to President Trump’s desk for his signature.

Kuster voted in favor of similar legislation, the Stopping Bad Robocalls Act (H.R.3375), in July.

More Solutions to Saving Energy in Your Home

This article concludes a four-week wrap up of the "Button Up" workshop in September. The Claremont Energy Advisory Committee felt that this was a powerful workshop for area residents and we wanted to give more widespread exposure to the essential tips relayed by representatives from "New Hampshire Saves" (a collaboration of the state's electric and natural gas utilities) and the Plymouth Area Renewable Energy Initiative.

It is no surprise that heating and cooling are the most significant energy users in a home. According to the U.S. Department of Energy, homeowners should "consider replacing existing heating systems under the following conditions:

- it is more than 15 years old
- repairs would cost more than fifty percent the cost of replacement
- the system is very inefficient

New energy heating or cooling equipment can reduce energy use by 20% or more, and combining new installations with recommended insulation, air sealing, and thermostat settings can cut heating and cooling bills in half.

Heat pumps are another option for both heating and cooling your home by collecting heat from the air, water, or ground and moving that air inside or out as desired. Cold-climate air-source heat pumps are designed specifically for cold climates and can extract heat from -20-degree air. Units can be placed in the wall of your home requiring no ductwork and can heat or cool individual rooms.

Water heating is the second largest expense in the home. It typically accounts for 13% of energy use. A few options to reduce water heating bills include:

- reduce hot water use, e.g. cold-water clothes washing,
- turn down the thermostat on the water heater,

- insulating water heater and pipes,
- installing low-flow showerheads and faucet aerators,
- consider a temperature-sensitive switch. If waiting for shower water to heat is an issue.
- replace an existing water heater with an energy efficient model. Options include tankless, heat pump, and solar heaters. Heat pump models are more efficient than regular electric.

NHSaves.com is a great resource for incentives details and rebates for the following types of equipment including mini split cold climate heat pumps, natural gas boilers, furnaces, hot water heaters, Wi-fi smart thermostats and heat pump electric hot water heaters. Home performance energy assessments with prioritized recommendations and low or no-interest financing options are available to qualified homeowners also.

City Addresses Late Mailing of Tax Bills This Year

CLAREMONT, NH—City Manager Ed Morris released a statement Tuesday afternoon addressing the later-than-usual mailing of tax bills:

“You might not be looking forward to receiving your tax bill, but you may be looking for it.

“This year your tax bill will be a little late due to several factors. The process has been on a slight delay from the very beginning.

“After a veto of the State budget and several weeks of negotiations, in September the State government reached a compromise on its budget. One of the critical elements included in the approved budget was the reinstatement of municipal aid.

“Claremont received its portion of the municipal aid in mid-October. Per state statute, a public hearing must be held to accept and expend the funds. This mandatory meeting is scheduled for December 12th and once concluded, the determination of what the School will do with the funds will be sent to the Department of Education and then to the Department of Revenue, where the tax rate will be set.

“After the City receives its tax rate, the warrant will be run and the tax collector will send out the tax bills. As usual, once the tax bills are sent out, the first payment will be due within thirty days.

“We thank you for your patience through this process and assure you that the City will do what it can to get the tax bills out in a timely manner.”

Claremont School District to Hold Second Special Meeting

CLAREMONT, NH—Due to a technical error in posting the notice of the recent public hearing regarding money coming from the state, the Claremont School District is holding a second such meeting to correct the matter. According to Claremont School Board Chair Frank Sprague, addressing the issue at the SAU meeting Thursday evening, “We didn’t put the notice of the public hearing on the SAU website page, our contention being that Claremont doesn’t have a website.” The Department of Revenue saw things differently, however, feeling that the district had “adopted

the SAU website”...“so we’re having another district meeting on the 12th to ratify and correct the defect,” said Sprague.

At the previous meeting held Nov. 21, voters approved the appropriation of \$650,000 for new and expanded special ed programs; the remaining \$650,000 will be returned to taxpayers to help offset the tax rate. The funding represents \$1.3 million in unanticipated revenue made available to the City that was made possible through the state budget adopted and signed into law by the governor. The district has said that by using the money for expanded in-district special ed programs, it will be able to lower costs by eliminating out-of-district costs for a number of students. It also hopes the local programs will bring in tuition-paying students from other districts, thus creating a new stream of revenue for the Claremont School District down the road.

The Dec. 12th meeting will be held at the Sevens High School auditorium, beginning at 6:30 p.m.

Deaf or Hard of Hearing Driver Visor Cards Now Available

CONCORD, NH – Governor Chris Sununu, the New Hampshire Commission on Deafness and Hearing Loss, and Department of Safety Commissioner Robert Quinn recently released

the New Hampshire Deaf or Hard of Hearing Driver Visor Card, a tool that facilitates communication and quickly notifies law enforcement and other emergency responders that a driver is deaf or hard of hearing, making interactions safer and easier.

“Any time law enforcement interacts with a citizen, it is critically important that good communication is established,” said Sununu. “This new visor card will help deaf and hard of hearing individuals communicate in a helpful, respectful, and streamlined manner with law enforcement, ensuring everyone is safe. This is an incredibly valuable tool.”

“Everyone at the Department of Safety wants to make sure all motorists in New Hampshire have a safe and pleasant experience,” Quinn said. “This visor card will allow law enforcement, other first responders, and deaf or hard of hearing motorists to communicate with one another more clearly and increase safety for everyone on New Hampshire’s roads.”

“This card will do much to ensure law enforcement and the deaf or hard of hearing motorist will be able to communicate in a helpful and respectful way,” said Representative Mark Pearson, chairman of the New Hampshire Commission on Deafness and Hearing Loss. “I am pleased that both the major stakeholders in the deaf or hard of hearing community, and New Hampshire law enforcement agencies are all signed on to this valuable new tool.”

While the use of the visor card is optional, any driver with a hearing impairment or who communicates in a language other than English is encouraged to keep the card ready and attached to the vehicle’s sun visor for use with emergency responders.

Visor cards are being distributed across the state for use by first responders, educators, town offices, and hospitals.

The driver visor card is available online and will be available across the state in the coming weeks. Cards can be picked up at locations providing services to deaf or hard of hearing individuals, like the New Hampshire Division of Motor Vehicles; the New Hampshire Department of Education, Bureau of Vocational Rehabilitation; audiologists’ offices; hearing care dealers; and law enforcement agencies.

Use Year-end Bonus (or Gift) Wisely

As 2019 draws to a close, you may be anticipating – or have already received – a year-end bonus from your employer. Or you might be receiving a substantial cash gift for the holidays. (If you're really lucky, you might get both.) You can doubtlessly think of many ways to spend this money right now, but how can you use it to help yourself in the long run?

Here are a few suggestions:

- **Pay off some debts.** Virtually all of us carry some type of debt, and that's not necessarily a bad thing. For example, your mortgage not only gives you a place to live and a chance to build equity in your home, but the interest payments are typically tax deductible. Other debts, though, such as those on consumer items, are not so positive – you generally can't deduct the interest payments, and the items themselves probably won't enhance your personal wealth. If you wait, you'll probably find other uses for this money. And if you're going to enjoy a comfortable retirement, you'll need to maximize every possible resource – and your IRA is one of your best ones. Furthermore, the sooner you get the money into your IRA, the more potential it will have to grow over time.

- **Feed your college fund.** If you're already contributing to a college fund for your young children or grandchildren, you can use your year-end bonus or monetary gift to add to the fund. If you haven't already started such an account, you might want to use this money for that purpose. You could open a 529 plan, which provides possible tax benefits and gives you control of the funds until it's time for them to be used for college or some type of vocational school. (Depending on where you live, you might also get tax benefits from your state if you use a 529 savings plan to pay for K-12 expenses.)

To achieve all your financial goals, you'll need to take advantage of your opportunities – and your year-end bonus or monetary gift can certainly be one of them.

One Skillet Meals

It's that time of year again when we get short of daylight and time in general. I've been having to do quick meals and don't seem to have much time for menu preparation. I like to know what I'm doing for dinner by at least 10:00 a.m. Lately, I've been doing everything at the last minute.

I like to buy chicken breasts in the large family packs and freeze some and cook up a big batch to have handy. I par boil several breasts so that I have a supply to work with through the week. Doesn't always work, but I try.

Anyway, I've been doing a lot of one skillet meals lately. I'll put on some rice and then see what I've got on hand. Usually, some chicken. Back to fried rice. If I'm doing other proteins like sausage or pork or shrimp, I add a little to the rice water for color or skip it as the mood strikes. I find that when I cook chicken, I also add some smoked paprika when I cook the chicken in the skillet. Does good things.

I used to do fried rice in a wok many years ago and seem to remember adding a beaten egg as a binder. Don't know why I stopped. I may start again.

When time and imagination get short, go with the one skillet meal. There are a ton of recipes out there and can be a great stress reliever. Just throw stuff in with some rice and veggies and it is a real easy meal. If it doesn't work out, there is always the phone.

Playing with food when stressed for time is a great way to discover new and exciting flavors. I always cook more meat than I need so that I have leftovers to base a meal on during the week. Even an extra pork chop or two makes another meal. Save the elaborate meals for the holidays and later in the winter.

I think I'm running out of space.

Remember to Remove Snow and Ice from Roofs

CONCORD, NH— State officials remind residents and business owners to consider removing snow and ice from roofs this winter. Heavy snowfall, sometimes followed by rain that cannot pour off the roof as it normally would, can cause additional weight and put stress on your building's roof.

"A roof may collapse with little or no warning, and one common misconception is that only flat roofs are susceptible," explained State Fire Marshal Paul Parisi. "With changing winter weather that can bring us snow, rain, and freezing rain in a short timeframe, it's important to regularly assess the roof of your home or business. If you're not sure of the weight capacity of your roof or if you think it may have been compromised, consult with a reputable builder and your local building or fire official."

Home and business owners are also encouraged to keep all chimneys and vents clear to prevent carbon monoxide from backing up into the building.

"Residents should make sure it is safe to remove the snow from roofs, especially pitched roofs, to prevent personal injury," says State Homeland Security and Emergency Management Director Jennifer Harper.

The following are snow removal safety recommendations:

- Use a long-handled roof rake and stand on the ground to remove snow from the roof.
- If you must use a ladder, make sure the base is secure.
- Ask someone to hold the ladder while you climb.
- Do not clear snow during periods of strong winds.
- If you see an electrical wire that may have fallen onto your roof, call 9-1-1 and do not touch it.
- Keep room drainage systems clear of snow to prevent the risk of roof ponding in the event of heavy snow melting.

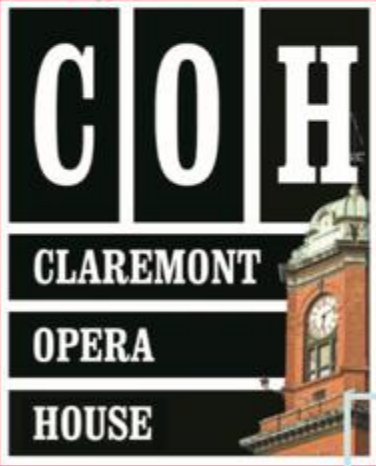
