

Zombeck Will Be Featured Speaker At St. Joe's Sports Night March 30th

CLAREMONT, NH--Amy Zombeck, a 1995 Stevens High School graduate and winningest coach in school history at UMass-Boston, will be the featured speaker at the 60th annual St. Joseph's Sports Night on March 30. Zombeck, who is the head coach in two sports, softball and soccer at the school, said, "I am very excited about the opportunity to speak."

While she may be anxious to speak what she has accomplished personally as a player and coach speaks for itself. At Stevens she was an all-New England soccer selection in 1994 and in 1995 was the Lions Cup most valuable player. In 2015 she was inducted into the Keene State College Hall of Fame and was the Little East Conference Player of the Year in 1998. She was the assistant women's head soccer coach at Keene State College from 2001-2004 before becoming the head soccer and softball coach at UMass-Boston in 2005. At the Boston campus Zombeck was selected as the Little East Soccer Coach of the Year three times and her team won the conference title in 2012, the same year her team made the NCAA tournament.

In the previous 59 years of the St. Joseph's Sports Night, an array of celebrities have spoken at the event including Carl Yastrzemski, Carlton Fisk, Bill Mombouquette, Dick McAuliffe and Johnny Pesky, from the Red Sox; Celtics owner Walter Brown and Jon Morris, Jim Whalen, Ron Burton and Mike Holovak from the Patriots. Bill Jackowski of nearby North Walpole, a National League umpire who was behind the plate when Pittsburgh's Bill Mazeroski hit a dramatic home run to beat the Yankees in the seventh game of the 1968 World Series, spoke twice as did former Dartmouth head football coach Joe Yukica. Other

football coaches to speak were Bill Bowes of the University of New Hampshire, Mickey Heineken of Middlebury College and Claremont's Larry MacElreavy of Columbia University.

The event, which starts at 6:00 p.m., is sponsored by the Claremont Lodge of Elks 879 and features a baked stuffed chicken dinner. Tickets for \$8 are available at Stevens High School and Marro Home Center.

Springfield Wrestling Draws Full House

SPRINGFIELD, VT--They came from Connecticut, Vermont, Massachusetts, New Hampshire, and New York. It

was wall-to-wall wrestling at Riverside Middle School on Saturday, March 5th. The parking lot was full, as was the gym and the cafeteria as 350+ wrestlers of all grades descended upon the building to grapple the day away.

The Springfield Wrestling Team hosts two annual tournaments, the Schweitzer Memorial Youth for boys and girls in grades K-8 and the Precision Valley Classic Girls Championships females in grades K-12. While the two events were held back-to-back on a Saturday and a Sunday in 2015, this year they were combined on Saturday and occasionally overlapped. Some 300 spectators filed in throughout the day to watch the action, enjoy a full concession stand, and browse the tables piled high with tee shirts, hoodies, and other wrestling gear, courtesy of Competitive Edge Wrestling. Two large wrestling mats were divided into five scoring areas, staffed by volunteers from the team and from the community. Referees travelled from as far as two hours away to work the event; local high school students donated some 147 hours of community service between Friday night's set-up and the 12-hour day on Saturday.

Wrestling is a growing sport at all levels, and the attention it gets at the Olympic and college levels are having a trickle-down effect through high school, middle school, and the elementary grades, right down to Kindergarten and pre-K.

The team was excited to learn that the tournament brought business to town beyond the competition: Holiday Inn Express booked at least 38 rooms for visitors staying overnight for the tournaments; The Sub-Way provided 50 pizzas for the tournaments and got additional

business after the events were over as wrestlers were leaving town at dinner-time. Team co-manager Kelly Stettner noted that "It feels great to be able to support some of our supporters!"

Among that list of supporters, Black River Produce provided a variety of fruits for fruit salad at the concession stand, HB Energy Solutions donated \$250 toward hot dogs and buns. JH Dunning provided a large box truck for moving wrestling mats between Park St School (where the team practices) and Riverside.

After expenses are tallied, the team expects to have netted close to \$5,000 in proceeds from the events, which will be used to keep the local program going - new uniforms and headgear for the upcoming season, funding team trips to wrestling camps and long-distance meets, and tournament fees throughout the six-month-long season.

"The team wishes to express our sincere thanks to everyone who donated food, time, and energy to the success of these tournaments, and to the Springfield Police Department for stopping by periodically to check in," said Stettner.

Annie's Project Provides Skill-Building & Networking for Women Farmers

More women are operating farms today in New Hampshire and neighboring Vermont and Massachusetts, according to the USDA Agriculture 2012 Census. Whether new or experienced farmers, business skills are essential to succeed in a farming operation. Through Annie's Project courses, farm women become empowered to be better business partners or sole operators through networks and by managing and organizing critical information.

Annie's Project is a discussion-based workshop series, bringing women together to learn from experts in production, financial management, human resources, marketing and the legal field. No matter if women are beginning farmers or experienced, the skills taught in Annie's Project benefits women at all stages in a farm business. The cost for the course is \$60 per person or \$90 per farm, which includes a workbook and support materials for all sessions. Lunch is provided at each session. 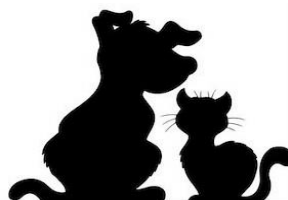

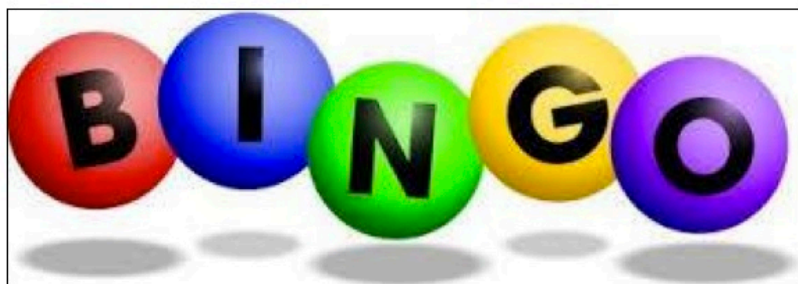

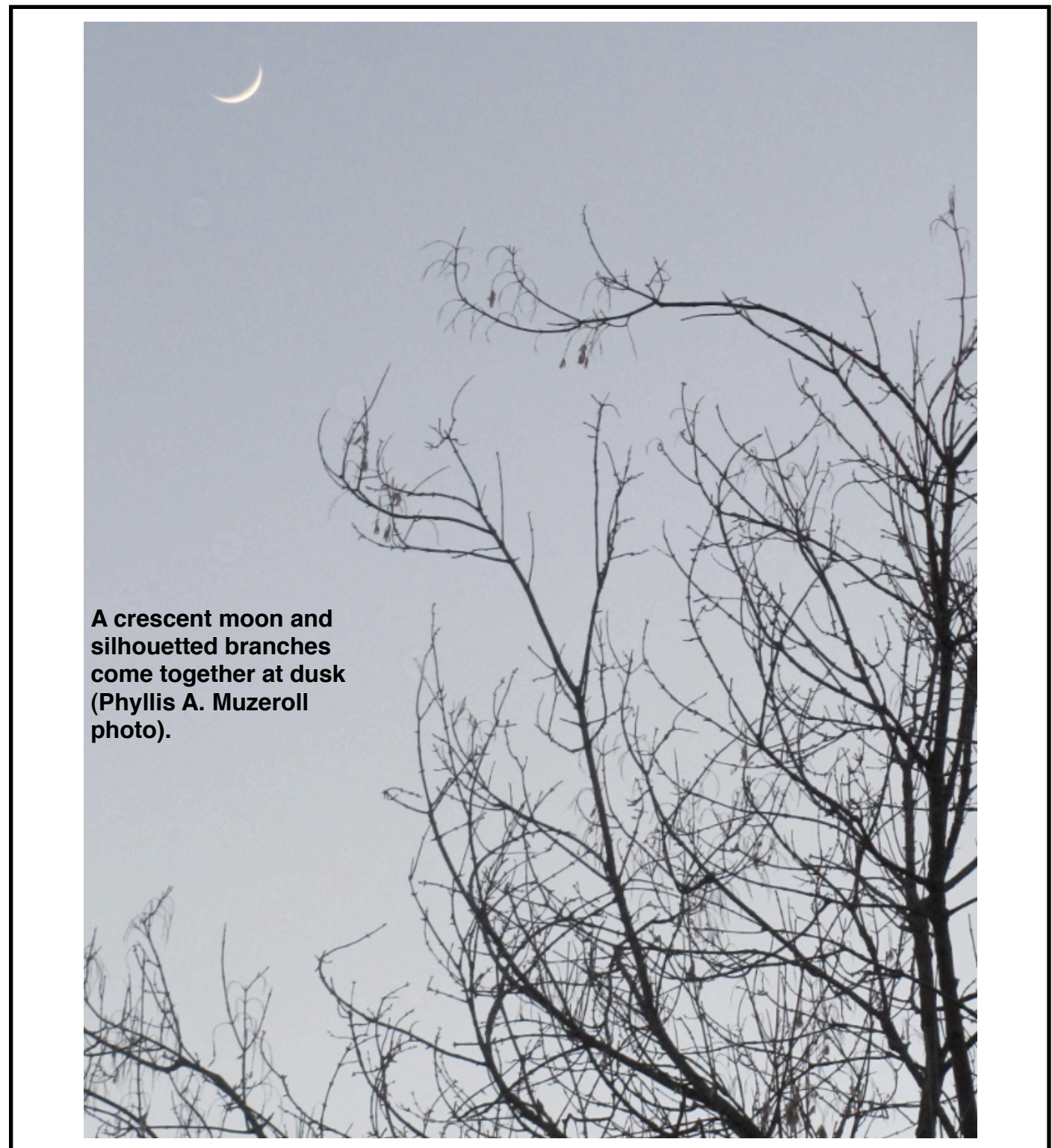

Access for the Disabled in Oklahoma City: Update

I previously wrote about a terrible experience that I had when attending a concert at an arena in Oklahoma City. To recap, I am disabled, and I was denied access to the front doors of the arena by one of the local law enforcement officers who shut down the street during events. It was only after much humiliation, and the officer realizing I know disability laws in my state, that I was allowed the proper access to the front doors of the arena. Before I continue, I must explain how unusual this is. Our officers here in Oklahoma are among the finest, and I love every one of them. In fact, my husband and I often secretly pay for their meals when we see any in restaurants. They work hard and put their lives on the line daily for us, and I am not afraid to stand up alongside any of them and take a bullet for one of them myself. To officers across the country, and especially within my home state, I say, "Thank you, and God bless you all!"

I heard back from Mayor Mick Cornett's office regarding the situation. Sadly, I still have not heard back from Governor Mary Fallin's office. A representative from the Mayor's office, Kristy Yager, Director of Public Information and Marketing, spoke with me at length, both over the phone and in person, regarding the issue. Afterward, I received a phone call from Pat Byrne, Security Manager over two of Oklahoma City's arenas, to further discuss the issue and get more information from me. Both Ms. Yager and Mr. Byrne were obviously upset by the way that I was treated and the lack of proper access that I, along with many others, faced that evening at the arena. They both apologized to me numerous times, and they thanked me for bringing this problem to their attention. As each one separately stated, they can neither know about nor fix problems unless people let them know the problems exist.

The way things are supposed to operate is simple: allow the driver of the disabled patron to drive through the barricades, park at the front door to drop off the disabled party, and then pull back out through the barricades to find a place to park within the designated parking areas. This was explained by both Ms. Yager and Mr. Byrne, and it is a very simple and easy to follow procedure. So, why then did this officer not follow procedure and behave so offensively toward me? Neither could answer that, and that's to be expected in all honesty. He could have had a bad day. He could have been feeling unwell. He could have not fully understood the procedure and didn't want to stop to take the time to discuss the matter with me. There are many possible reasons (some reasonable, some not so reasonable), and it would be merely speculation to assume as to one over another. I will neither speculate nor be angry. I will simply thank Ms. Yager and Mr. Byrne for taking the time to speak with me, to listen to the details, and to show that my home state truly cares about its citizens and patrons to the many public access areas.

I was very happy to receive the reception that was given to me by Ms. Yager and Mr. Byrne. I could see that they truly cared about this issue, and I fully believe their assurances that they will take the proper steps to address and correct the problem for future events, including making sure the officers are fully aware of the proper procedures. Our men and women in blue in Oklahoma are phenomenal, and I fully support and thank them for all that they do each and every day. I state again that this officer's behavior was most unusual for Oklahoma. I am proud to be an Oklahoman, and this is why. We care about everyone, in spite of race, creed, color, religion, or physical capabilities. Oklahoma strong, through and through.
